**GAMES WILL BE PLAYED SEPTEMBER 10TH-OCT 18TH.** GAMES WILL BE ON TUESDAY/THURSDAY, HOWEVER, OTHER DAYS MAY BE UTILIZED IF NECESSARY. THE SEASON MAY BE EXTENDED TO ACCOMMODATE MAKE UP DATES.

LEAGUE FEE INCLUDES A SHIRT AND PARTICIPATION AWARD. PLAYERS ARE RESPONSIBLE FOR PROVIDING SHIN GUARDS AND APPROPRIATE SHORTS, SHOES, AND/OR CLEATS. MINOR AND MAJORS WILL NEED SOCCER CLEATS. TENNIS SHOES OR CLEATS ARE APPROPRIATE FOR ALL OTHER AGE GROUPS. PRACTICES WILL BE DETERMINED BY COACHES. ROSTERS WILL BE COMPLETED AFTER THE FINAL REGISTRATION AND COACHES WILL SCHEDULE PRACTICE AT THAT TIME.

BUDDY SOCCER IS INSTRUCTIONAL ONLY AND IS INTENDED TO INTRODUCE CHILDREN TO WORKING AS A TEAM AND VERY BASIC IDEAS OF SOCCER. THEY DO NOT PLAY GAMES. SESSIONS ARE HELD ON TUESDAYS AT 6PM.

PEE WEE IS AN INTRODUCTION TO THE GAME OF SOCCER. PLAYERS CONTINUE TO LEARN THE IDEAS OF THE GAME AND DEVELOP SOCIALIZATION AND TEAM SKILLS. THERE ARE NO REFEREES. GAMES ARE PLAYED ON THURSDAYS AT 6PM AND 7PM.

MINORS/MAJORS CONTINUE INTO MORE ADVANCED SKILL DEVELOPMENT. THESE GAMES ARE OFFICIATED. TEAMS WILL BE FORMED BASED ON AGE AND REGISTRATION NUMBERS. THEY WILL PRACTICE AND PLAY GAMES IN A FRIENDLY LEARNING ENVIRONMENT WHERE THEY CAN CONTINUE TO IMPROVE, DEVELOP, AND BUILD CONFIDENCE.
