LEAGUE FEE INCLUDES A SHIRT AND PARTICIPATION AWARD. HATS ARE PROVIDED FOR MINOR AND MAJOR BASEBALL ONLY. PLAYERS ARE RESPONSIBLE FOR PROVIDING BASEBALL PANTS OR APPROPRIATE SHORTS, SHOES AND/OR CLEATS, AND A GLOVE. MINOR AND MAJOR WILL NEED CLEATS. TENNIS SHOES OR CLEATS ARE APPROPRIATE FOR ALL OTHER AGE GROUPS. COACHES WILL HAVE A BAG OF EQUIPMENT INCLUDING CATCHERS GEAR, HELMETS, BATS, AND BALLS.
