Renewal applications not <u>received</u> by <u>June 30<sup>th</sup></u> will be subject to a late fee of 5%; with an additional 5% penalty assessed the first of each month thereafter. Renewals delinquent past <u>August 31<sup>st</sup></u>, will be subject to having their license revoked. New licenses issued after January 1<sup>st</sup> will be prorated by 50%.
