#### NEW BUSINESS:

A. BILL NO. 2018-38, ORDINANCE 353- AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A RENEWAL CONTRACT BY AND BETWEEN THE CITY OF WARSAW AND OZARK DISPOSAL FOR THE WEEKLY PICKUP OF RESIDENTIAL SOLID WASTE.
