ORDINANCES

Bill No. 2022-11, Ordinance No 467- An Ordinance authorizing the Mayor to execute a contract by and between the City of Warsaw and J&N Utilities for the 2021 SRF Water System Improvements, Federal Project DW291293-02.

City Administrator Randy Pogue discussed this ordinance. City Administrator Randy Pogue and City Attorney Cale Haddock explained the process of annexation. A hand out was presented to the board explaining the process. This ordinance will be placed on another council meeting.

RESOLUTIONS

Resolution 2022-03, Resolution authorizing the Mayor to execute a contract by and between the City of Warsaw and Professional Turf Products for a tax-exempt lease, for the reimbursement of expenditures which the city already made. It will be used to reimburse the costs of financing the 2016 Triflex 3320.

City Administrator Randy Pogue explained that we budgeted \$35,000.00 for a new green's mower in our 2022 Budget. At this time, we are not guarantee delivery this year and what we have will not survive another year. Bryan Minnis located a 2016 refurbished TriFlex 3320 Green mower, 11 blade reels, groomer brushes, rear roller brushes-1695 hours for \$29,500.00, 48 months, 4 years \$8,117.28 (\$676.44 per month).

City Administrator Randy Pogue updated the board on the sales tax, Auditor Jon Cummings letter and the increase of \$1,011,900 in fund balances.

MDNR SEWER MASTER PLAN

City Administrator Randy Pogue updated the board. We budgeted a 10% match requirement and the grant amount must not exceed \$50,000.00 we received an email after reviewing the city's demographic information and user charge, the city may be eligible for 100% grant up to \$62,500.00. This would be used to video camera and sewer expansion.

MDNR WATER MASTER PLAN

City Administrator Randy Pogue updated the board on the MDNR Water Master Plan. We received an email that the City may be eligible for funding through the DWERG program in the amount of \$7,500.00 and the city should begin working on the procurement of an engineering firm.

Police Chief Sean McCannon arrived at 6:15 pm.
