# A. Bill No. 2021-31, Ordinance No 454- MegaKC, Project (FEMA, 12033 DR 4551)

City Administrator Randy Pogue discussed the bids we received for the Steamboat Landing Boardwalk. The city received two bids, FEMA and SEMA accepted the bid from MegaKC. Aldermen Flores made a motion to authorize the Mayor to execute an agreement by and between the City of Warsaw and MegaKC for the Steamboat Landing, Federal Project (FEMA) 12033 DR4551, Boardwalk on the Lake, for \$654,400.00.
